



Memorandum of Understanding (MOU)

Between the Society of Urologic Oncology (SUO) and Society of Genitourinary Oncology – India.

Purpose

This Memorandum of Understanding (MOU) outlines the collaborative partnership between the Society of Urologic Oncology (SUO) and Society of Genitourinary Oncology - India, aiming to foster mutual educational and professional development opportunities for members of both societies.

Joint Initiatives

SUO Winter Meeting Participation

Society of Genitourinary Oncology - India will be invited to participate in an International Roundtable Meeting held during the SUO Winter Meeting.

A representative from Society of Genitourinary Oncology - India may be invited to serve as a panelist or moderator when applicable during the Winter Meeting.

Mutual Representation

The SUO and Society of Genitourinary Oncology - India, when able, will send a representative to each other's respective annual meetings to enhance international exchange and maintain organizational visibility.

Joint Webinars

SUO and Society of Genitourinary Oncology - India will collaborate to develop and host joint webinars intended for members of both societies.

Topics, scheduling, and speaker selections will be coordinated by a designated liaison from each organization.

Programs

The SUO and Society of Genitourinary Oncology - India may review, develop, and implement educational or exchange programs by mutual agreement. These programs are intended to foster academic collaboration and facilitate the sharing of clinical and research expertise, as agreed upon by both parties. Each participating organization will be responsible for providing funding for its own representatives involved in any agreed-upon program.

Evaluation and Continuation

The said commitments are agreed for two (2) years and may be renewed after evaluation by SUO and Society of Genitourinary Oncology - India. All activities will be evaluated by both Society of Genitourinary Oncology - India and SUO in writing or during a virtual meeting.

The outcome of these evaluations will determine the continuation of this MOU. Both parties will confirm - in writing - whether or not parties have the intention to continue the MOU for the following year. This will be done three (3) months before the starting date of the potential new extension of the MOU.

The parties as mentioned in this MOU duly sign this Agreement on (02/08/2025) and agree that it shall be considered effective immediately.


